## Fee Schedule

This is our basic fee schedule. From time to time other issues may arise that we will discuss and mutually agreed upon.

#### **Startup Fees:**

One-time Bookkeeping Set-up Fee	\$150.00
Maintenance Account Deposit	\$300.00

#### **Service Fees:**

Tenant Screening (paid by tenant)	\$30.00/per applicant
Leasing Fee	50% of 1 <sup>st</sup> Month's Rent
Monthly Property Management	8%-10% of Annual Gross Rent + Expenses
Annual Lease Renewals	\$295.00
Repairs & Maintenance	5% charge over the service provider's fee
Extended Vacancy Fee	\$50.00 per month
Evictions:	\$295 + fees set by eviction service company

#### **Tenant Procurement Only:**

\$750.00 One-time fee, 50% due at time of listing, balance due upon tenant move-in. (no bookkeeping)
